

Home Team Responsibility

- Check with the visiting coach mid-week prior to the game to coordinate jersey colors. In case of conflict visiting team changes.
- Provide a quality game ball. Referee has the authority to accept or reject the ball.
- Rescheduling rain cuts as described below.

Conduct

Each coach is responsible to all the soccer clubs for the conduct of his/her players and spectators. Coaches must exercise every reasonable precaution against disturbance or disorderly conduct before, during and after each match.

Game Cancellation Procedure

If you must cancel or reschedule a game please follow the procedure outlined below. This does not apply to rainouts. Coaches are responsible for rescheduling their own games, fields, and referees due to rainouts.

- Both coaches must agree to the change.
- The home team coach (listed first on the schedule) is responsible for notifying the Referee Scheduler that the game is canceled.
- The Referee Scheduler must be notified by Wednesday at 5PM prior to the game date.
- If the Referee Scheduler is not notified by Wednesday at 5PM the coaches are responsible for paying the referees for that game.
- If a coach fails to notify the Referee Scheduler a second time that coach will be fined \$25.00 by the club that scheduled the referees for the game. The fine must be paid before the next game.
